- All feed is to be kept in rodent-proof containers
- There shall be no outside slaughtering of birds

# Keeping Chickens in Red Bank

## General Provisions

- Properties zoned R-1 & R-1 A may be eligible to keep up to four (4) hens/female chickens (subject to conditions and requirements). Properties of two (2) or more acres a maximum of eight (8) hens will be allowed. Not allowed on properties that are multi-family complexes /duplexes, or office/commercial space. Properties bordering on Stringers Branch are not eligible.

## Application Fee & Permit Required

- Annual application fee of fifty dollars (\$50.00)
- Must include site plan (location of the structure)
- To apply for a permit visit [redbanktn.gov](http://redbanktn.gov), go to citizen portal, then select Chicken Permit application
- Permit must be issued and enclosure must be inspected & approved before use occurs

## Placement of Coop

Enclosures may NOT be placed in front yards, must be placed in rear yard

- Coop location shall not be visible from the street
- Setbacks from any adjoining property lines shall be a minimum of twenty-five (25) feet
- Setbacks from streams shall be a minimum of fifty (50) feet

## Waste Disposal Method

- Chicken litter, manure, and waste must be disposed of in a manner consistent with current best practices.
- Disposal, compost, or waste bins where chicken-related waste is disposed of shall be stored at least twenty-five (25) feet from any adjoining side and rear property lines and at least fifty (50) feet from any stream.
- City of Red Bank will accept disposal of a small amount of waste in your city issued garbage receptacle with the following restrictions applied:
  - All waste must be double bagged in a durable/sturdy trash bag designed to hold household trash. Grocery carry-out bags will not be accepted
  - Ten (10) pound limit per week, accumulating waste for monthly, or less frequent disposal may not exceed ten (10) pounds.
  - Failure to follow these disposal restrictions will result in their chicken permit revoked in accordance with Section 4, (a)(2)(o) of the subject ordinance.

## Construction

- Minimum cage size of two (2) square feet for the inside enclosure for each bird
- Outside runs shall be a minimum of eight (8) square feet per hen and enclosed with wire or screen on all sides of enclosure
- Windows & vents shall be covered with predator & bird-proof wire of less than one (1") inch openings
- Structure shall be uniform and shall be in harmony with the surrounding area.
- Access doors shall be shut & locked at night

## Additional Requirements

- Enclosure shall be well maintained
- Enclosures must be kept in a neat & sanitary condition at all times, and waste must be disposed of properly
- Enclosure must be cleaned regularly to prevent offensive odors
- Chickens must be kept/raised in a manner to ensure humane treatment, while also providing safe & healthy living conditions for the chickens and reducing adverse impacts on other residents in the neighborhood
- **Running at large is prohibited**, must be kept in a secure enclosure at all times
- **No Roosters permitted** or allowed anywhere in the city
