Dayton Blvd, From Signal Mountain Blvd North to Newberry Street East

1. The language of Agreement # 200269 dated October 28, 2020 Exhibit A is hereby deleted in its entirety and replaced with the attached Exhibit A for Amendment 1 .
2. The language of Agreement # 200269 dated October 28, 2020 Section B.2a) is hereby deleted in its entirety.
3. The following is added as B.2a).

B.2a) The Agency agrees to complete the herein assigned phases of the Project on or before **February 3, 2025**. If the Agency does not complete the herein described phases of the Project within this time period, this Agreement will expire on the last day of scheduled completion as provided in this paragraph unless an extension of the time period is requested by the Agency and granted in writing by the Department prior to the expiration of the Agreement. An extension of the term of this Agreement will be effected through an amendment to the Agreement. Expiration of this Agreement will be considered termination of the Project. The cost of any work performed after the expiration date of the Agreement will not be reimbursed by the Department.

All provisions of the original contract not expressly amended hereby shall remain in full force and effect.
